RESOLUTION NO. SP- **2030** S-2003

A RESOLUTION URGING THE HONORABLE FELICIANO R. BELMONTE, JR., CITY MAYOR, QUEZON CITY, TO IMPLEMENT THE PROVISIONS OF QUEZON CITY ORDINANCE NO. SP-154, S-94 IN FAVOR OF THE RETIRED, DECEASED, AND DISABLED MEMBERS OF THE CENTRAL POLICE DISTRICT COMMAND.

WHEREAS, on January 25, 1994 the Quezon City Council has enacted Ordinance No. SP-154, S-94, entitled: "An ordinance extending financial assistance by way of additional retirement benefit as well as for death or total disability benefit to members of the Central Police District and appropriating funds for the purpose", and the same was approved on February 14, 1994 by then City Mayor Ismael A. Mathay, Jr.;

WHEREAS, after the approval of said ordinance only few retirees were able to avail of the benefits thereof due to financial constraints of the city government;


