A RESOLUTION AUTHORIZING THE HONORABLE FELICIANO R. BELMONTE, JR., CITY MAYOR, THIS CITY, TO ACCEPT THE DONATION OF THE NATIONAL HOUSING AUTHORITY (NHA) IN FAVOR OF THE CITY GOVERNMENT OF THAT PARCEL OF LAND IDENTIFIED AS ROAD LOT 9, PSD-10781 LOCATED AT BARANGAY NAYONG KANLURAN, ALSO THIS CITY, AND CONSISTING OF AN AREA OF ONE THOUSAND EIGHT HUNDRED FIFTY-NINE (1,859) SQUARE METERS.
