
A RESOLUTION URGING HONORABLE FELICIANO R. BELMONTE, JR., CITY MAYOR OF QUEZON CITY, TO REQUEST THE LOCAL SCHOOL BOARD TO APPROPRIATE THE AMOUNT NECESSARY FROM THE SPECIAL EDUCATION FUND FOR THE RENOVATION AND RECONSTRUCTION OF THE EXISTING ONE-STOREY BUILDING OF BETTY GO-BELMONTE ELEMENTARY SCHOOL, BGY. DOÑA IMELDA, 4TH DISTRICT, QUEZON CITY, INTO A TWO-STOREY BUILDING.

WHEREAS, there is an urgent need for the renovation and reconstruction of the existing one-storey building of Betty Go-Belmonte Elementary School, Bgy. Doña Imelda, 4th District, Quezon City, into a two-storey building due to the significant and continuing increase in the enrollment of students every school year;

Doña Imelda, 4th District, Quezon City, into a two-storey building.
