A RESOLUTION URGING THE CITY MAYOR FELICIANO BELMONTE, JR. TO OFFER TO BUY THE PARCEL OF LAND AT NO. 66-D BANAHAW ST., BARANGAY SAN MARTIN DE PORRES, CUBAO, QUEZON CITY, FOR THE BENEFIT OF THE TWELVE (12) FAMILIES RESIDING THEREAT, THRU THE COMMUNITY MORTGAGE PROGRAM (CMP).

WHEREAS, the residents of San Martin de Porres consisting of twelve (12) families have requested thru this barangay that the lot they are occupying at present be awarded to them under the Community Mortgage Program (CMP);

WHEREAS, as per Resolution No. BS-77, S-2001 of Barangay San Martin De Pores, the barangay leaders have supported the residents' request and have certified to the fact that said residents have been occupying the said property for more than fifty (50) years;


WHEREAS, Republic Act 7279, otherwise known as the Urban Development and Housing Act of 1992 mandates the government to provide low cost and affordable housing to homeless and urban poor families, such as the twelve (12) families living at No. 66-D Banahaw Street, Barangay San Martin de Porres, Cubao, Quezon City;

WHEREAS, there is no cogent reason why the twelve (12) families should be deprived or prevented from owning the parcel of land they are occupying.


NOW, THEREFORE,
