RESOLUTION NO. SP2039, s-2003

RESOLUTION URGING THE CITY MAYOR. HONORABLE FELICIANO -R BELMONTE, JR.. TO -DIRECT THE PUBLIC ASSISTANCE AND LEGAL AID OFFICE (PALAO) TO CONDUCT FREE LEGAL AID CLINIC AT LEAST ONCE A WEEK AT THE BARANGAY LEVEL TO EXCLUSIVELY ENTERTAIN AND ACT ON COMPLAINTS AND GRIEVANCES OFINDIGENT AND UNDERPRIVILEGED RESIDENTS OF THE SAID BARANGAY IN QUEZON CITY.

WHEREAS, that Public Assistance and Legal Aid Office (PALAO,) as one of its duties and functions, shall extend and render free legal aid, advice, opinion, documentation and other legal assistance to all residents of Quezon City who are qualified under Ordinance No. NC-83, S-89;

WHEREAS, numerous complaints and grievances among the indigent and underprivileged residents of Quezon City are not attended to because their lowly status in life incapacitate them from hiring lawyers;

WHEREAS, as a consequence, these unfortunate residents of the City are beginning to lose faith in the capacity of the City government to protect them with equal justice;

WHEREAS, it is imperative that the Quezon City government should extend free legal assistance to indigent and underprivileged residents, protect their rights to life and property, and restore their faith and confidence in the government.
