WHEREAS, Section 480 of the Local Government Code provides that the appointment of an Administrator "shall be mandatory for the provincial and city governments";

WHEREAS, the same provision stipulates that the said official "shall take charge of the office of the administrator";

WHEREAS, Section 454 (d), also of the Local Government Code, requires that appointments of heads of departments and offices issued by the City Mayor shall be with the concurrence of the City Council;

WHEREAS, the confirmation of the appointment of Atty. Ochoa as City Government Head III (City Administrator) of Quezon City by the City Council will complete the substantive and procedural requirement set forth by the Civil Service Rules and Regulations regarding appointments of this nature.
