A RESOLUTION AUTHORIZING THE ISSUANCE OF A SPECIAL USE PERMIT TO UNIOIL PETROLEUM PHILIPPINES, INC. FOR THE OPERATION OF A GASOLINE FILLING STATION LOCATED AT LOTS 6 AND 8, NEOPOLITAN SUBDIVISION, REGALADO AVENUE, BARANGAY PASONG PUTIK, QUEZON CITY.

WHEREAS, petitioner Unioil Petroleum Philippines, Inc., a duly registered juridical entity is applying for the issuance of a Special Use Permit (SUP) for the operation of one of its gasoline filling station as part of the expansion program of its facilities in Quezon City, has identified a particular area located at Lots 6 and 8, Neopolitan Subdivision, Regalado Avenue, Barangay Pasong Putik, Quezon City;

WHEREAS, filling stations are among the uses which require a Special Use Permit upon authorization from the Quezon City Council as provided in Ordinance No. SP-918, S-2000, otherwise known as the Quezon City Comprehensive Zoning Ordinance of 2000;

WHEREAS, Unioil Petroleum Philippines, Inc., has complied with the requirements for the issuance of a Special Use Permit as required by the said Ordinance;


