WHEREAS, the Senior Citizen Association of Barangay Tatalon does not have enough budget to buy their own place for their permanent office.


WHEREAS, the Barangay Council of Barangay Tatalon, Quezon City, expresses their full support to this measure.


NOW, THEREFORE,


