RESOLUTION NO. SP2050, S-2003

A RESOLUTION URGING THE TRAFFIC ENGINEERING CENTER OF THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS TO INSTALL A FUNCTIONING TRAFFIC LIGHT AT THE CORNER OF P. TUAZON AVENUE AND LAKANDULA STREET IN PROJECT 4, DISTRICT III, QUEZON CITY.

WHEREAS, the intersection of P. Tuazon Avenue, a national road, and Lakandula St., a City road, is bounded by three (3) barangays, namely Barangay Marilag, Barangay Bagumbuhay and Barangay Milagrosa;

WHEREAS, aside from such, the Project 4 Public Merket, the Jose P. Laurel High School, Belarmino Elementary School, and Pura V. Kalaw Elementary and High Schools are all located within the premises of this intersection;

WHEREAS, with the large number of pedestrians and large volume of vehicles passing through this intersection, it is a common place of accidents and mishaps on a daily basis;

WHEREAS, this intersection has been a gridlock of traffic flow during rush hours because of the lack of personnel and facilities in managing the flow of traffic;

WHEREAS, there is a need for the City Council, as the legislative body of the city government, to enact resolutions that will ensure the safety and welfare of the city and its constituents.
