A RESOLUTION URGING QUEZON CITY MAYOR FELICIANO R. BELMONTE, JR., TO GRANT FINANCIAL ASSISTANCE TO THE VICTIMS OF THE FIRE THAT OCCURRED ON DECEMBER 18, 2002 AT TARHA VILLE, BARANGAY STA. LUCIA, NOVALICHES, QUEZON CITY, COMPRISING OF NINETEEN (19) FAMILY HOMEOWNERS AT TWO THOUSAND PESOS (P2,000.00) EACH AMOUNTING TO THIRTY-EIGHT THOUSAND PESOS (P38,000.00) TO BE TAKEN FROM ANY AVAILABLE FUNDS OF THE CITY TREASURY.




WHEREAS, a fire occurred on December 18, 2002 at Tarha Ville, Barangay Sta. Lucia, this City, rendering nineteen (19) family homeowners homeless;

WHEREAS, Section 458 (1) (iv) of the Local Government Code of 1991 empowers the sangguniang panlungsod to "adopt measures to protect the inhabitants of the city from the harmful effects of man-made or natural disasters and calamities and to provide relief services and assistance to victims during and in the aftermath of said disasters or calamities and their return to productive livelihood following said events.

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to urge, as it does hereby urge, Quezon City Mayor Feliciano R. Belmonte, Jr., to grant financial assistance to the victims of the fire that occurred on December 18, 2002, at Tarha Ville, Barangay Sta.


