“The sangguniang panlungsod, as the legislative body of the city, shall enact ordinances, approve resolutions and appropriate funds for the general welfare of the city and its inhabitants pursuant to Section 16 of this Code and in the proper exercise of the corporate powers of the city as provided for under Section 22 of this Code, and shall.”

(a)(5)(v) "Regulate the use of streets, avenues, alleys, sidewalks, bridges, parks and other public places and approve the construction, improvement, repair and maintenance of the same; establish bus and vehicle stops and terminals or regulate the use of the same by privately-owned vehicles which serve the public; regulate garages and the operation of conveyances for hire; designate stands to be occupied by public vehicles when not in use; regulate the putting up of signs, signposts, awnings and awning posts on the streets; and provide for the lighting, cleaning and sprinkling of streets and public places;"


WHEREAS, such priority projects to be installed and constructed are vital to the health, safety, and development of the barangay;

WHEREAS, the Barangay Council of Barangay Dofia Imelda adopted its Resolution No. 104-S-2001 endorsing for approval the priority projects of their barangay for the year 2003;


NOW, THEREFORE,
