RESOLUTION NO. SP **2063**S-2003

A RESOLUTION RATIFYING THE CONTRACTS OF SERVICE ENTERED INTO BY AND BETWEEN THE CITY GOVERNMENT, REPRESENTED BY THE HONORABLE FELICIANO R. BELMONTE, JR., AND MAGWOODS, INC., REPRESENTED BY MR. CESAR P. MAGSAYSAY AND HALREY CONSTRUCTION, INC., REPRESENTED BY MR. CELSO R. HALILI, FOR THE HAULING OF FILLING MATERIALS, CRUSH ROCKS, ESCOMBRO AND TOPSOIL, FROM THE CONTRACTORS' QUARRY SITE TO PAYATAS DUMPSITE.

WHEREAS, the Honorable City Mayor, Feliciano R. Belmonte, Jr., in his memorandum dated December 4, 2002, has requested the City Council, certifying as urgent the ratification of the contracts of service entered into by the city government with Magwoods, Inc. and Halrey Construction, Inc. for the hauling of filling materials, crush rocks and escombros from the contractors quarry site to Payatas Dumpsite;


WHEREAS, the recent fires that took place at the Payatas Dumpsite caused by the spontaneous combustion of methane gas have not only posed danger to the lives of the residents living thereat, but also caused damage to the dumping tables and roadways along the slopes of the dumpsite;

WHEREAS, the city government has expressed that the most effective way to suppress and arrest these fires is by covering the dumpsite with topsoil;

WHEREAS, Magwoods Inc. and Halrey Construction, Inc., offered their services to provide hauling at the Payatas dumpsite under the terms and conditions of the contract of service.







NOW, THEREFORE,
