
WHEREAS, there is a need to continuously provide logistical support to the Special Action Team which was created under the Executive Order No. 17, Series 2002;

WHEREAS, the primary concern of the city is to improve its aesthetic condition and avoid possible serious sanitation and health problem of its residents.








NOW, THEREFORE,
