RESOLUTION NO. SP-**2073**, S-2003

A RESOLUTION AUTHORIZING THE HONORABLE FELICIANO R. BELMONTE, JR., CITY MAYOR OF QUEZON CITY, TO NEGOTIATE FOR THE EXTENSION OF THE SERVICE CONTRACTS FOR GARBAGE HAULING AND DISPOSAL INCLUDING THE HEAVY EQUIPMENT AT THE PAYATAS DUMPSITE AND OTHER PARTS OF QUEZON CITY, UNDER THE SAME TERMS AND CONDITIONS FOR THE PERIOD COVERING APRIL 1 TO JUNE 30, 2002, PENDING THE SELECTION OF THE WINNING BIDDERS FOR THE SOLID WASTE COLLECTION AND DISPOSAL, AND CLEANING SERVICES UNDERTAKEN BY THE BIDS AND AWARDS COMMITTEE.


WHEREAS, the awarding and proclamation of the winning bidders for the solid waste collection and cleaning and disposal services scheduled last March 27, 2002, was deferred by the Bids and Awards Committees;

WHEREAS, the deferment was due to the prior request made by the participating bidders to postpone the equipment inspection of their equipment after the holy week, in order for them to undertake a more extensive preparation before the conduct of the inspection;

WHEREAS, this will also provide the Bids and Awards Committee ample time to conduct the post evaluation procedures including the physical inspection of bidder's equipment to ensure the most competent and deserving bidders to be chosen;

WHEREAS, considering the urgency of addressing this perennial problem on waste disposal, the City is mandated under the Local Government Code to provide uninterrupted solid waste collection and disposal services to its constituents and the public in general;


WHEREAS, it would work to the advantage and benefit of the City to extend the service contracts of garbage haulers and heavy equipment at the Payatas dumpsite for the period April 1 to June 30, 2002, until the Bids and Awards Committee has finally chosen and affirmed the winning bidders of the supposed project.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to authorize, as it does hereby authorize, the Honorable Feliciano R. Belmonte, Jr., to negotiate for the extension of the service contracts for garbage hauling and disposal including the heavy equipment at the Payatas dumpsite and other parts of Quezon City, under the same terms and conditions for the period covering April 1 to June 30, 2002, pending the selection of the winning bidders for the solid waste collection and disposal, and cleaning services undertaken by the Bids and Awards Committee of Quezon City.

RESOLVED, FURTHER, that this resolution shall take effect immediately upon its approval.
