A RESOLUTION OPPOSING THE IMPLEMENTATION OF THE METRO MANILA DEVELOPMENT AUTHORITY (MMDA) RESOLUTION NO. 02-36, S-2002, ON THE MORATORIUM ON THE GRANTING OF FRANCHISE TO NEW TWO-STROKE MOTORIZED TRICYCLES.

WHEREAS, Metro Manila Council passed a resolution, MMDA Resolution No. 02-36, S-2002, urging the local government units of Metropolitan Manila to implement a moratorium on the granting of franchise to new two stroke motorized tricycle in Metro Manila starting January 1, 2003;

WHEREAS, the resolution is perceived by some to be unreasonable and discriminatory because the issuance of the tricycle franchise should not be used as a requirement for compliance to emission standards since it is not mandated under the Clean Air Act;

WHEREAS, there is a great possibility that mass unemployment would result among tricycle drivers all over the country if the government pushes through with its plan to ban two strokes tricycles.


