RESOLUTION NO. SP-2075S-2003

A RESOLUTION AUTHORIZING THE HONORABLE FELICIANO R. BELMONTE, JR., CITY MAYOR, THIS CITY, TO ENTER INTO A NEGOTIATED CONTRACT WITH ANY REPUTABLE AND QUEZON CITY ACCREDITED CONSTRUCTION CORPORATION FOR THE DRAINAGE IMPROVEMENT AND CONCRETING OF CAMBRIDGE STREET, BARANGAY E. RODRIGUEZ, QUEZON CITY, FROM ANY AVAILABLE FUND.

Introduced by Councilors JULIAN M. L. COSETENG, ELIZABETH A. DELARMENTE, JORGE L. BANAL, FRANZ S. PUMAREN, WENCEROM BENEDICT C. LAGUMBAY, DIORELLA MARIA SOTTO-DE LEON and DANTE M. DE GUZMAN.

WHEREAS, Section 16 of R.A. 7160, otherwise known as the Local Government Code of 1991, provides, to wit:

“Every local government units shall exercise the powers expressly granted x x x as well as powers necessary to x x x, promote health and safety, x x x and preserve the comfort and convenience of their inhabitants.”

WHEREAS, Cambridge Street is a vital artery, which serves as alternate route from Diliman to Cubao area, and has been effective in easing the traffic at the intersection of EDSA and Kamias Street;

WHEREAS, Cambridge Street is too narrow and has perennially been in a dilapidated condition and always required regular asphalt patching due to its soft base;

WHEREAS, the City government has seen the need to improve and widen this street so as to maximize its role in serving the public;

WHEREAS, on January 8, 2003, the area along Cambridge Street where informal settlers live was razed by fire;


WHEREAS, due to the incident, the City government in the interest of the general public decided that this is the opportune time to push through with the improvement of the said street;
