A RESOLUTION AUTHORIZING THE EMERGENCY PURCHASE OF ONE (1) SECOND HAND 1997 ISUZU FUEGO 4X4 PICK-UP FROM MR. DOMINGO ROBEL AT FIVE HUNDRED FIFTY THOUSAND PESOS (P550,000.00) TO BE USED BY THE PAYATAS OPERATIONS GROUP, AND AUTHORIZING THE CITY MAYOR, HONORABLE FELICIANO R. BELMONTE, JR., TO SIGN THE DEED OF ABSOLUTE SALE FOR THE PURPOSE.




NOW, THEREFORE,


