A RESOLUTION URGING THE HONORABLE FELICIANO R. BELMONTE, JR., CITY MAYOR OF QUEZON CITY, TO DIRECT THE CENTRAL POLICE DISTRICT OFFICE (CPDO) OR THE OFFICE AND/OR AGENCY CONCERNED IN COORDINATION WITH THE RESPECTIVE BARANGAY OFFICIALS OF QUEZON CITY, TO ENFORCE AND ENSURE THE IMPLEMENTATION OF CITY ORDINANCES.

WHEREAS, the implementation and enforcement of city ordinances by concerned agencies is a clear indication of an efficient and effective city government.




