RESOLUTION NO. SP **2080** S-2003

A RESOLUTION URGING HONORABLE QUEZON CITY MAYOR FELICIANO R. BELMONTE, JR., TO REQUEST THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS, QUEZON CITY, TO CONSIDER THE FEASIBILITY OF CONSTRUCTING A COVERED PEDESTRIAN OVERPASS ACROSS COMMONWEALTH AVENUE NEAR THE INTERSECTION OF IBP ROAD, BARANGAY COMMONWEALTH, QUEZON CITY.

WHEREAS, with the road widening of Commonwealth Avenue, there is neither traffic light/s nor pedestrian crossing lane at the intersection of IBP Road, Brgy., Commonwealth, such that innumerable constituents coming from Payatas, Litex and Bagong Silangan have to cross Commonwealth Avenue to get a ride at the other side, going towards the direction of the Quezon Memorial Circle, are ever apprehensive of being hit by speeding motor vehicles while dashing across the said street;

WHEREAS, the nearest pedestrian overpass in the vicinity is at Mangahan Market, more than kilometer away which is very far and inaccessible to the above-mentioned pedestrians/constituents;



Belmonte, Jr., to request the Department of Public Works and Highways, Quezon City, to consider the feasibility of constructing a covered pedestrian overpass across Commonwealth Avenue near the intersection of IBP Road, Barangay Commonwealth, Quezon City.
