RESOLUTION NO. SP-**2086**S-2003

A RESOLUTION RATIFYING THE MEMORANDUM OF AGREEMENT ENTERED INTO BY AND BETWEEN THE QUEZON CITY GOVERNMENT, REPRESENTED BY THE CITY MAYOR, HONORABLE FELICIANO R. BELMONTE, JR., MANILA WATER COMPANY, INC., REPRESENTED BY ITS PRESIDENT, MR. ANTONIO T. AQUINO, AND BARANGAY BAGUMBAYAN, REPRESENTED BY ITS CHAIRMAN, MR. ISABELO M. VICTORINO, ON 13 APRIL 2002.

WHEREAS, it is the duty and function of the Quezon City government to provide basic services and facilities, aside from preserving the comfort and convenience of its inhabitants;

WHEREAS, the replacement of the existing 100 mm diameter ACP pipeline along Calle Industria going to San Roque Street, Quezon City, due to its defective state, is an infrastructure facility concerning the water supply systems intended primarily to service the needs of the residents therein;

WHEREAS, in discharging its duties and functions necessary, appropriate or incidental to the efficient and effective provisions of the above-mentioned basic services and facilities, the Honorable City Mayor, the Manila Water Company, Inc. and Barangay Bagumbayan, have agreed to share in the total cost of said project estimated at Five Million One Hundred Seven Thousand Two Hundred Fourteen Pesos and Ten Centavos (P5,107,214.10) and, pursuant thereto, the Honorable City Mayor entered into a Memorandum of Agreement with the Manila Water Company, Inc.,

through its President, Mr. Antonio T. Aquino, and Barangay Bagumbayan, through its Chairman, Isabelo M. Victorino, on 13 April 2002 for the replacement of the existing but defective 100 mm diameter ACP pipeline along Calle Industria going to San Roque Street, Quezon City;


WHEREAS, the said Memorandum of Agreement executed by the parties, dated 13 April 2002, requires the ratification of the Quezon City Council.
