RESOLUTION NO. SP-**2087**S-2003

A RESOLUTION URGING HIS HONOR, CITY MAYOR FELICIANO R. BELMONTE, JR., TO CONTINUOUSLY TRANSFER AND DEPOSIT THE REAL PROPERTY TAX SHARES OF THE DIFFERENT BARANGAYS FROM THE CITY TREASURY TO THEIR RESPECTIVE ACCREDITED DEPOSITORY BANKS.

WHEREAS, Section 271 (d) of Republic Act 7160, otherwise known as the Local Government Code of 1991, as amended, provides, that "The share of each barangay shall be released, without need of any further action, directly to the barangay treasurer on a quarterly basis within five (5) days after the end of each quarter and shall not be subject to any lien or holdback for whatever purpose.";

WHEREAS, transferring the shares of barangays in the real property taxes to their respective depository banks will enable them to promptly settle their legal and contractual obligations and thus hasten their fullest development as sustainable and effective communities;

WHEREAS, such transfer should be done in accordance with the existing laws, rules and regulations.

NOW, THEREFORE,


BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to urge, as it does hereby urge, His Honor, City Mayor Feliciano R. Belmonte, Jr., to continuously transfer and deposit the real property tax shares of the different barangays from the City Treasury to their respective accredited depository banks.

RESOLVED, FUTHER, that all barangays without depository banks up to the present shall be required by the City Treasurer to open their respective bank accounts for the purpose of remittance.

RESOLVED, FINALLY, that copies of this Resolution be furnished to the City Mayor for his information and appropriate action, and to all Barangay Chairmen in Quezon City, for their information and reference.
