RESOLUTION NO. SP-**2091**, S-2003

A RESOLUTION STRONGLY SUPPORTING SENATE BILL NO. 140, AN ACT CREATING AND ESTABLISHING THE CENTER FOR STUDIES ON INDIGENOUS CULTURAL COMMUNITIES, APPROPRIATING FUNDS THEREFOR AND FOR OTHER PURPOSES.

WHEREAS, Article II, Section 22 of the Philippine Constitution, states that, "the State recognizes and promotes the rights of indigenous cultural communities within the framework of national unity and development;"

WHEREAS, likewise in Article XII, Section 5 and Article XIV, Section 17 of the Constitution, provides that the State shall protect their rights to their ancestral lands, respect and protect their cultures, traditions and communities;

WHEREAS, in the light of the above provisions, it is imperative that the government should adopt policies and programs for indigenous cultural communities;

WHEREAS, such bill will ensure that these policies and programs are based on facts and judgment;

WHEREAS, it is necessary to have this enacted in order to have a continuing in-depth study of the indigenous cultural communities who should also participate in such study.


