RESOLUTION NO. SP-**2095**, S-2003

A RESOLUTION REQUESTING THE CITY MAYOR, HONORABLE FELICIANO R. BELMONTE, JR., TO ALLOCATE THE NECESSARY FUNDS FOR THE PURCHASE OF A PARCEL OF LAND FOR THE CONSTRUCTION OF A BARANGAY HALL OF BARANGAY STO. NIÑO, GALAS, DISTRICT IV, QUEZON CITY.

WHEREAS, in a communication, dated 19 August 2002, addressed to Hon. Sergio C. Gonzalvo, Punong Barangay of Barangay Sto. Niño, Galas, Quezon City, Mr. Jesus P. Escano through his brother and Attorney-in-fact, Mr. Jesus P. Escano, signified his intention to sell his vacant lot located at No. 99 Union Civica Street, Barangay Sto. Niño, Galas, Quezon City, (as evidenced by Transfer Certificate of Title No. 264177) with a total lot area of One Hundred Fifty (150) square meters at Fifteen Thousand Pesos (P15,000.00) per square meter;

WHEREAS, the above-mentioned parcel of land is estimated to have a cost of approximately Two Million Two Hundred Fifty Thousand Pesos (P2,250,000.00) while the remaining balance of Five Million Pesos (P5,000,000.00) will be used as an initial fund for the construction of the barangay hall of Barangay Sto. Niño, Galas, Quezon City;

WHEREAS, at present, Barangay Sto. Niño is renting a barangay hall with a limited office space and it is only proper that the Barangay Council of Barangay Sto. Niño should have its own barangay hall through the purchase of private lots.


