RESOLUTION NO. SP-**2101**, S-2003

A RESOLUTION AUTHORIZING THE CONSTRUCTION OF A NEW BARANGAY HALL OF BARANGAY SIENA AT THE CORNER OF BINGO AND DON JOSE STREETS, AMOUNTING TO ONE MILLION PESOS (P1,000,000.00), THE AMOUNT TO BE TAKEN FROM THEIR OWN BARANGAY BUDGET.

WHEREAS, there is a need to transfer the location of the barangay hall of Barangay Siena to an appropriate area at the corner of Bingo and Don Jose Streets just across the location of the existing barangay hall;

WHEREAS, at present, the said barangay is occupying a prescribed area along the sidewalk of Sto. Domingo Street beside Siena College;

WHEREAS, the said existing barangay was constructed twenty (20) years ago and has already deteriorated and needs immediate renovation and relocation;

WHEREAS, in compliance with the thrust of the City government to clear the sidewalks and streets of illegal structures, the said barangay is initiating the transfer of the same to a proper and vacant area within the territorial jurisdiction of the barangay;

WHEREAS, the proposed barangay hall will be constructed in an excess lot thereby necessitating an authorization from the City Council;

WHEREAS, as per ocular inspection conducted by the Office of the City Engineer, it is recommended that the proposed site can be utilized for the said purpose;
