RESOLUTION NO. SP- 2102 S-2003

A RESOLUTION AUTHORIZING THE HONORABLE FELICIANO R. BELMONTE, JR., CITY MAYOR, TO ENTER INTO A NEGOTIATED CONTRACT WITH IRA GENERAL AND SECURITY SERVICES, INC., FOR THE TWELVE (12) AGENCY HIRED JANITORIAL AND MAINTENANCE PERSONNEL FOR THE PERIOD OF JANUARY TO JUNE 2003.

WHEREAS, that every first quarter of the year is an anticipation of a tax month where a large volume of taxpayers are expected;

WHEREAS, the desire to improve our frontline function which is the maintenance of all comfort rooms for the convenience of the taxpayers and encourage them to pay their taxes regularly;

WHEREAS, to be assured that the City's funds shall not be put into waste in this endeavor considering that it would be the taxpayers who shall primarily benefit from this project;

WHEREAS, the convenience during the first quarter of the year is of prime importance and intends to deploy these twelve (12) personnel at the ground floor where we have ten (10) comfort rooms, including the covered walks, hallways and lobbies which we also need to keep clean.
