RESOLUTION NO. SP-2110, S-2003

A RESOLUTION GRANTING FINANCIAL ASSISTANCE TO THE VICTIMS OF FIRE THAT OCCURRED IN NO. 23 ROTC HUNTERS STREET, BARANGAY TATALON, DISTRICT IV, QUEZON CITY, ON MARCH 30, 2003, THE AMOUNT TO BE TAKEN FROM THE CALAMITY OR EMERGENCY FUND OF THE GOVERNMENT OR ANY AVAILABLE FUNDS OF THE CITY GOVERNMENT.

WHEREAS, a fire engulfed No. 23 ROTC Hunters Street, Barangay Tatalon, District IV, Quezon City, last March 30, 2003, burning to the grounds the homes of over One Hundred Fifty (150) families;

WHEREAS, it has been the practice of the City government to help victims of the unfortunate event by way of financial assistance to help them in their hour of need.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to grant, as it does hereby grant, financial assistance to the victims of the fire that occurred in No. 23 ROTC Hunters Street, Ergy. Tatalon, District IV, Quezon City, on March 30, 2003, the amount to be taken from the Calamity or Emergency Fund of the City government or any available funds of the City, as follows:


House Owners	-	P 4,000.00 each
House Renters	-	2,000.00 each
House Sharers	-	1,000.00 each

RESOLVED, FURTHER, that the Social Services Development Department (SSDD) shall validate and authenticate the list of fire victims categorized into family owners and family renters/sharers and to submit the same to the Office of the City Mayor, likewise making representation for the early release of the financial assistance to the qualified recipients.
