RESOLUTION NO. SP- **2112**, S-2003

A RESOLUTION AUTHORIZING THE HONORABLE FELICIANO R. BELMONTE, JR., CITY MAYOR, QUEZON CITY, TO EXTEND THE SERVICE CONTRACTS FOR HEAVY EQUIPMENT ENTERED INTO BY AND BETWEEN THE CITY GOVERNMENT, MAGWOODS, INC., REPRESENTED BY MR. CESAR P. MAGSAYSAY AND HALREY CONSTRUCTION, INC., REPRESENTED BY MR. CELSO R. HALILI, FOR THE DAY TO DAY OPERATIONS OF THE PAYATAS DUMPSITE FOR THE PERIOD COVERING JANUARY 1, 2003-JUNE 30, 2003.

WHEREAS, the Honorable City Mayor, Feliciano R. Belmonte, Jr., in his memorandum dated March 3, 2002, has requested the City Council, certifying as urgent the extension of the contract of service entered into by the City government with Magwoods, Inc. and Halrey Construction, Inc., under the same terms and conditions for the period covering January 1, 2003-June 30, 2003;

WHEREAS, police power is conferred upon local government units under Section 16 of the Local Government Code, which provides, thus, "Every local government unit shall exercise the powers expressly granted, those necessary and proper for governance such as to promote **health and safety** x x x" (emphasis provided);

WHEREAS, there is an urgent need for the use of heavy equipment which are vital in the collection and disposal of garbage as well as the maintenance of the Payatas Dumpsite in order not to interrupt the daily operations of the said disposal site;

WHEREAS, Magwoods, Inc. and Halrey Construction, Inc., have the appropriate number of heavy equipment needed for the operation and offered their services for the use thereof which contract ended last December 31, 2002.


NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to authorize, as it does hereby authorize, the Honorable Feliciano R. Belmonte, Jr., City Mayor, Quezon City, to extend the service contracts for heavy equipment, entered into by and between the City government, MAGWOODS, Inc. represented by Mr. Cesar P. Magsaysay and HALREY CONSTRUCTION, INC., represented by Mr. Celso R. Halili, for the day to day operation of the Payatas dumpsite for the period covering January 1, 2003-June 30, 2003.


