RESOLUTION NO. SP 2114, S-2003

A RESOLUTION URGING QUEZON CITY MAYOR, HONORABLE FELICIANO R. BELMONTE, JR., TO GRANT FINANCIAL ASSISTANCE TO THE VICTIMS OF THE FIRE THAT OCCURRED ON FEBRUARY 15, 2003 AT THE PAGKAKAISA COMPOUND, BARANGAY CULIAT, QUEZON CITY, COMPRISING OF TWO HUNDRED (200) FAMILIES AT TWO THOUSAND PESOS (P2,000.00) EACH IN THE TOTAL AMOUNT OF FOUR HUNDRED THOUSAND PESOS (P400,000.00) TO BE TAKEN FROM ANY AVAILABLE FUNDS IN THE CITY TREASURY.

WHEREAS, a fire occurred on February 15, 2003 at about 11:00 o'clock a.m. at Pagkakaisa Compound, Barangay Culiati, this City, rendering two hundred (200) families homeless;

WHEREAS, Section 458 (1) (iv) of the Local Government Code of 1991 empowers the sangguniang panlungsod to "adopt measures to protect the inhabitants of the city from the harmful effects of man-made or natural disasters and calamities, and to provide relief services and assistance for victims during and in the aftermath of said disasters or calamities and in their return to productive livelihood following said events";
