A RESOLUTION AMENDING RESOLUTION NO. SP-1900, S-2003, ENTITLED, "A RESOLUTION AUTHORIZING DR. VICTOR B. ENDRIGA, CITY TREASURER, THIS CITY, TO UNDERTAKE THE REPAIR AND RENOVATION OF THE CITY TREASURER'S OFFICE LOCATED AT THE GROUND FLOOR OF THE QUEZON CITY HALL MAIN BUILDING".

WHEREAS, the said measure authorizes Dr. Victor B. Endriga, City Treasurer, this City, to undertake the repair and renovation of the City Treasurer's Office located at the ground floor of the Quezon City Hall main building;

WHEREAS, the Honorable Feliciano R. Belmonte, Jr., City Mayor, should be the one authorized to negotiate with any accredited contractor for the said repair and renovation instead of Dr. Victor Endriga;


