A RESOLUTION AUTHORIZING THE ISSUANCE OF SPECIAL USE PERMIT TO NATION GASOLINE CORPORATION FOR THE CONSTRUCTION OF A REFILLING GASOLINE STATION LOCATED AT 1382 E. RODRIGUEZ SR. BLVD., CORNER MABOLO ROAD, BARANGAY MARIANA, NEW MANILA, QUEZON CITY.

WHEREAS, petitioner Nation Gasoline Corporation, a duly registered juridical entity is applying for the issuance of a Special Use Permit (SUP) for the construction of one of its gasoline service station as part of the expansion program of its facilities in Quezon City, has identified a particular area located at 1382 E. Rodriguez Sr. Blvd., corner Mabolo Road, Barangay Mariana, New Manila, Quezon City.

WHEREAS, refilling stations are among the uses which require a Special Use Permit upon authorization from the Quezon City Council as provided in Ordinance No. SP-918, S-2000, otherwise known as the Quezon City Comprehensive Zoning Ordinance of 2000;

WHEREAS, Nation Gasoline Corporation, has complied with the requirements for the issuance of a Special Use Permit as required by said ordinance;
