A RESOLUTION AUTHORIZING THE ISSUANCE OF A SPECIAL USE PERMIT TO UNIOIL PETROLEUM PHILIPPINES, INC., FOR THE OPERATION OF A GASOLINE FILLING STATION LOCATED AT NO. 37 QUEZON AVENUE, BARANGAY LOURDES, QUEZON CITY.

WHEREAS, petitioner Unioil Petroleum Philippines, Inc., a duly registered juridical entity has applied for the issuance of a Special Use Permit (SUP) for the operation of one of its gasoline filling stations located at No. 37 Quezon Avenue, Barangay Lourdes, Quezon City, as part of the expansion program of its facilities;

WHEREAS, Unioil Petroleum Philippines, Inc., has complied with the requirements for the issuance of a Special Use Permit as required by said ordinance;


WHEREAS, the operation of a gasoline filling station will promote public welfare and economic development, through the projected increase of employment opportunities in our City.
