A RESOLUTION URGING HIS HONOR, CITY MAYOR FELICIANO R. BELMONTE, JR., TO CONSTITUTE A CONFERENCE COMMITTEE COMPOSED OF MEMBERS OF THE CITY COUNCIL AND THE OFFICE OF THE CITY MAYOR FOR THE ATTAINMENT OF A COMMON UNDERSTANDING AND HARMONIOUS RELATIONSHIP BETWEEN THE TWO BRANCHES OF THE CITY GOVERNMENT TOWARD THE PASSAGE AND EFFECTIVITY OF PROPOSED MEASURES PENDING FINAL CONSIDERATION BY THE CITY COUNCIL.

WHEREAS, it is imperative that a Conference Committee be created for the purpose of facilitating an immediate and common understanding over the meaning and implications of a particular proposed measure before its approval.


