A RESOLUTION AMENDING RESOLUTION NO. SP-2064, S-2003, ENTITLED, "A RESOLUTION AUTHORIZING HIS HONOR, FELICIANO R. BELMONTE, JR., TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE SAMAHANG TAWID SAPA DOS PHASE I HOMEOWNERS ASSOCIATION, FOR THE DIRECT SALE OF SEVERAL PARCELS OF LAND WITH A TOTAL AREA OF TWENTY THOUSAND SIX HUNDRED FORTY-TWO SQUARE METERS (20,642 SQ.M.) SITUATED IN TAWID SAPA I, BARANGAY KALIGAYAHAN, QUEZON CITY."


