A RESOLUTION AUTHORIZING THE ISSUANCE OF A SPECIAL USE PERMIT TO ARCADIO B. REYES, OWNER/DEALER OF FLYING V GASOLINE FILLING STATION, FOR THE CONSTRUCTION OF A GASOLINE FILLING STATION LOCATED AT GENERAL LUIS ST., CORNER DAMONG MALIIT ST., BARANGAY NAGKAIKANG NAYON, NOVALICHES, QUEZON CITY.

WHEREAS, petitioner Arcadio B. Reyes, owner/dealer of Flying V gasoline filling station, is applying for the issuance of a Special Use Permit (SUP) for the construction of one of its gasoline filling stations located at General Luis St. corner Damong Maliit St., Barangay Nagkaisang Nayon, Novaliches, Quezon City, classified as a Medium Intensity Industrial (I-2) Zone, as part of the expansion program of its facilities in Quezon City;

WHEREAS, filling stations are among the uses which require a Special Use Permit upon authorization from the Quezon City Council as provided in Ordinance No. SP-918, S-2000, otherwise known as the Quezon City Comprehensive Zoning Ordinance of 2000;

WHEREAS, Arcadio B. Reyes, owner/dealer of Flying V gasoline filling station, has complied with the requirements for the issuance of a Special Use Permit as required by said ordinance;


