RESOLUTION NO. SP-2147, S-2003

A RESOLUTION REQUESTING THE CITY MAYOR TO ALLOCATE THE AMOUNT OF TEN MILLION PESOS (P10,000,000.00) FROM ANY AVAILABLE INFRASTRUCTURE FUND FOR THE CONSTRUCTION OF A 3-STOREY MULTI-PURPOSE BARANGAY HALL FOR BARANGAY MILAGROSA.

WHEREAS, City Council Ordinance No. SP-756, S-99, was approved on January 26, 1999 donating a parcel of City-owned land under Transfer Certificate of Title No. 61383 to Barangay Milagrosa;

WHEREAS, in pursuance of the aforecited ordinance, the Quezon City government, represented by then City Mayor Ismael A. Mathay, Jr., executed a Deed of Donation on March 30, 2001 over the subject property in favor of Barangay Milagrosa;

WHEREAS, among the projects included in the development plan approved by the Hon. Feliciano R. Belmonte, Jr., City Mayor, for the subject land are a tennis court, a covered basketball court, parks and playground, a dog pound and an eco-system;

WHEREAS, among the uses for the proposed barangay multi-purpose hall envisioned on the donated property is to house the barangay office, a senior citizens office, an SK office, a health center and a post office extension, all comprising a floor area of One Thousand Five Hundred Sixty (1,560) square meters in a 3-storey building.
