RESOLUTION NO. SP-2154, S-2003

A RESOLUTION PROVIDING FINANCIAL ASSISTANCE TO THE FAMILY OF THE LATE HONORABLE ROGER R. ESCOLANO, FORMER BARANGAY CAPTAIN, BARANGAY DIOQUINO ZOBEL, DISTRICT III, THIS CITY, IN THE AMOUNT OF THIRTY THOUSAND PESOS (P30,000.00) TO BE CHARGED FROM GRANTS, SUBSIDIES AND CONTRIBUTIONS OF THE 2003 ANNUAL BUDGET OF THE OFFICE OF THE CITY MAYOR OR FROM ANY AVAILABLE FUNDS IN THE CITY TREASURY.
