A RESOLUTION AUTHORIZING THE ISSUANCE OF A SPECIAL USE PERMIT (SUP) TO SEAOIL PETROLEUM CORPORATION FOR THE CONSTRUCTION OF A GASOLINE STATION LOCATED AT 152 A. BONIFACIO AVENUE, CORNER SCOUT ALCARAZ STREET, LA LOMA, QUEZON CITY.

WHEREAS, the construction of a gasoline refilling and service station will promote public welfare as well as to improve commerce and employment in Quezon City.




NOW, THEREFORE,


