RESOLUTION NO. SP-**2156**, S-2003

A RESOLUTION AUTHORIZING QUEZON CITY VICE MAYOR, HONORABLE HERBERT M. BAUTISTA, TO ENTER INTO A NEGOTIATED CONTRACT WITH ANY REPUTABLE CONTRACTOR FOR THE INSTALLATION AND FABRICATION OF BASKETBALL BOARDS, INSTALLATION AND FABRICATION OF TRAFFIC SIGNS, ROAD IMPROVEMENTS THROUGH THE INSTALLATION OF PEDESTRIAN LANES, IMPROVEMENT OF DAY-CARE CENTERS AND WAITING SHEDS IN THE DIFFERENT BARANGAYS LOCATED IN THE SECOND DISTRICT OF QUEZON CITY IN AN AMOUNT NOT EXCEEDING ONE MILLION TWO HUNDRED FIFTY THOUSAND PESOS (P1,250,000.00) TO BE CHARGED AGAINST THE CAPITAL OUTLAY FOR PUBLIC INFRASTRUCTURE OF THE QUEZON CITY COUNCIL'S BUDGET FOR 2003.

Introduced by Councilor VOLTAIRE GODOFREDO L. LIBAN III.

WHEREAS, the installation and fabrication of basketball boards, installation and fabrication of traffic signs, road improvements through the installation of pedestrian lanes, improvement of day-care centers and waiting sheds in the different barangays located in the Second District of Quezon City are among the priority development projects of the Quezon City government;

WHEREAS, time is of the essence in the implementation of said project in the face of beautification of every barangay and other factors affecting the early completion of said project;

WHEREAS, there is a sense of urgency and a felt need to immediately finish said project in order to provide comfort to and convenience of the residents of said barangays;

WHEREAS, in order to avoid unnecessary delay which normally attends in public bidding, there is a felt need to authorize the City Vice Mayor of Quezon City, Honorable Herbert M. Bautista to enter into a negotiated contract with any reputable contractor for the installation and fabrication of basketball boards, installation and fabrication of traffic signs, road improvements through the installation of pedestrian lanes, improvement of day-care centers and waiting sheds in the different barangays in the Second District of Quezon City.

Bautista, to enter into a negotiated contract with any reputable contractor for the installation and fabrication of basketball boards, installation and fabrication of traffic signs, road improvements through the installation of pedestrian lanes, improvement of day-care centers and waiting sheds in the different barangays located in the Second District of Quezon City in an amount not exceeding One Million Two Hundred Fifty Thousand Pesos (P1,250,000.00) to be charged against the Capital Outlay for Public Infrastructure of the Quezon City Council's Budget for 2003.
