A RESOLUTION ALLOCATING THE AMOUNT OF ONE HUNDRED TWENTY THOUSAND PESOS (P120,000.00) FROM THE OFFICE OF THE CITY MAYOR OR FROM ANY AVAILABLE FUNDS OF THE CITY TREASURY FOR THE INSTALLATION OF TWO (2) ARTESIAN WELLS IN BARANGAY APOLONIO SAMSON, QUEZON CITY.

WHEREAS, water is one of the basic necessities of hum an being;



WHEREAS, to lessen the burden of the barangay inhabitants and to minimize their household expenses, two (2) artesian wells must be installed in Barangay Apolonio Samson, Quezon City.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to allocate, as it does hereby allocate, the amount of One Hundred Twenty Thousand Pesos (P120,000.00) from the Office of the City Mayor or from any available funds of the City Treasury for the installation of two (2) artesian wells in Barangay Apolonio Samson, Quezon City.
