RESOLUTION NO. SP-2162, S-2003

A RESOLUTION AMENDING RESOLUTION NO. SP-1950, S-2002 AUTHORIZING QUEZON CITY MAYOR, HONORABLE FELICIANO R. BELMONTE, JR., TO ENTER INTO A NEGOTIATED CONTRACT WITH ANY REPUTABLE CONTRACTOR FOR THE CONCRETING OF PATHWALKS AT VARIOUS LOCATIONS IN DISTRICT TWO OF QUEZON CITY IN AN AMOUNT NOT EXCEEDING ONE MILLION SIX HUNDRED FIFTY-FIVE THOUSAND EIGHT HUNDRED TWENTY TWO PESOS (P1,655,822.00) TO BE CHARGED AGAINST THE LUMP SUM APPROPRIATION FUND UNDER THE OFFICE OF THE CITY MAYOR.

WHEREAS, the construction and improvement of pathwalks along alleys in the different barangays located in Second District of Quezon City is among the priority development projects of the Quezon City government;

WHEREAS, time is of the essence in the implementation of the said project because of the uncertainties, weather conditions, and increasing cost of labor and construction materials;

WHEREAS, there is a sense of urgency, and a felt need to immediately finish said project in order to provide for the comfort and convenience of the residents of said barangays who have long suffered from the existing unattended conditions of said pathwalks;

WHEREAS, in order to avoid unnecessary delay which normally attends in public bidding, there is a felt need to authorize the City Mayor of Quezon City, Honorable Feliciano R. Belmonte, Jr., to enter into a negotiated contract with any reputable contractor, for the improvement and concreting of pathwalks along alleys in the different barangays of the Second District of Quezon City;

WHEREAS, pursuant to Section 455 (b) (1) (vi) of R.A. 7160, otherwise known as the Local Government Code of 1991, the city mayor as the chief executive of the city government, shall represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations; and such other documents upon authority of the sangguniang panlungsod or pursuant to law or ordinance.

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to authorize, as it does hereby authorize, the City Mayor, Honorable Feliciano R. Belmonte, Jr., to enter into a negotiated contract with any reputable contractor for the concreting of pathwalks at various locations in District II of Quezon City in an amount not exceeding One Million Six Hundred Fifty-Five Thousand Eight Hundred Twenty-Two Pesos (P1,655,822.00) to be charged against the Lump Sum Appropriation Fund under the Office of the City Mayor.
