
RESOLUTION NO. SP-**2163**, S-2003

A RESOLUTION RATIFYING THE MEMORANDUM OF AGREEMENT ENTERED INTO BY AND BETWEEN THE QUEZON CITY GOVERNMENT REPRESENTED BY THE CITY MAYOR, HONORABLE FELICIANO R. BELMONTE, JR., AND PHILIPPINE ECONOMIC ZONE AUTHORITY (PEZA), REPRESENTED BY ITS DIRECTOR GENERAL MRS. LILIA B. DE LIMA, FOR THE ADMINISTRATION ON THE NATIONAL BUILDING CODE OF THE PHILIPPINES (NBCP) IN PEZA-REGISTERED INFORMATION TECHNOLOGY (IT) PARKS AND BUILDINGS IN QUEZON CITY.

WHEREAS, the Building Code of the Philippines (NBCP) requires owners/operators of buildings, establishments and facilities, as well as enterprises that occupy or use them to secure Building and Occupancy Permits and other related permits from the Building Official of their local government units (LGUs) and for the buildings, establishments, facilities and enterprises that occupy or use them to be annually inspected by the Building Official;

WHEREAS, the Philippine Economic Zone Authority (PEZA) is authorized to enforce and administer the NBCP inside PEZA-registered economic zones by virtue of Presidential Decree No. 1786 issued on January 15, 1981, amending P.D. No. 66 (The Charter of the Export Processing Zone Authority or EPZA), in relation to R.A. 7916 (Special Economic Zone Act of 1995) and EO No. 282 dated 30 October 1995;


 

WHEREAS, PEZA and the Quezon City government are willing to coordinate and cooperate for the timely issuance of National Building Code of the Philippines permit required for buildings, structures and facilities in IT Parks and Buildings located in Quezon City.


NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to ratify, as it does hereby ratify, the Memorandum of Agreement entered into by and between the Quezon City government represented by the City Mayor, Hon. Feliciano R. Belmonte, Jr., and Philippine Economic Zone Authority (PEZA), represented by its Director General, Mrs. Lilia B. De Lima, for the administration on the National Building Code of the Philippines (NBCP) in PEZA-registered IT Parks and Buildings in Quezon City.
