RESOLUTION NO. SP-2165, S-2003

A RESOLUTION AUTHORIZING HIS HONOR, CITY MAYOR FELICIANO R. BELMONTE, JR., TO ENTER INTO A NEGOTIATED CONTRACT WITH ANY REPUTABLE CONTRACTOR OR SUPPLIER FOR THE FABRICATION AND INSTALLATION OF INFORMATIONAL BILLBOARDS AND FABRICATION OF PUSH CARTS TO BE GIVEN TO THE VARIOUS BARANGAYS LOCATED IN THE FIRST DISTRICT OF QUEZON CITY IN AN AMOUNT NOT EXCEEDING ONE MILLION TWO HUNDRED FIFTY THOUSAND PESOS (P1,250,000.00) TO BE CHARGED AGAINST THE CAPITAL OUTLAY FOR PUBLIC INFRASTRUCTURE OF THE QUEZON CITY COUNCIL'S BUDGET FOR 2003.

Introduced by Councilor BERNADETTE HERRERA-DY.

WHEREAS, Section 455 (b)(1)(vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that the City Mayor shall "represent the City in all its business transactions and sign in its behalf all bonds, contracts, and obligations and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance;

WHEREAS, the fabrication and installation of information billboards, and fabrication of push carts to be given to the various barangay located in the First District of Quezon City are among the priority projects of the Quezon City government;

WHEREAS, such projects are aimed to provide convenience and comfort to the residents of the First District of Quezon City;

WHEREAS, time is of the essence in the implementation of the said projects since they are urgently needed in the barangay communities;

WHEREAS, in view of their urgency, it is felt that the fabrication and installation of such necessities should be undertaken immediately.




