RESOLUTION NO. SP-**2166**, S-2003

A RESOLUTION AUTHORIZING HIS HONOR FELICIANO R. BELMONTE, JR., CITY MAYOR, TO NEGOTIATE FOR THE ACQUISITION OF A PIECE OF LAND CONTAINING, MORE OR LESS, TWO HUNDRED NINETY-TWO SQUARE METERS AND FIFTY SQUARE DECIMETERS (292.50 SQ.M.) REGISTERED IN THE NAME OF ELIZABETH M. MAHAYAG MARRIED TO MARIO P. MAHAYAG WITH TRANSFER CERTIFICATE OF TITLE NUMBERED RT-60637 (339103) ISSUED BY THE REGISTER OF DEEDS OF QUEZON CITY, AND LOCATED AT PELAEZ ST., BARANGAY BAYANIHAN, QUEZON CITY, TO BE USED AS THE SITE OF BARANGAY HALL OF BARANGAY BAYANIHAN.

WHEREAS, there is a letter-request from the Punong Barangay and the members of the Sangguniang Barangay of Barangay Bayanihan, District III, Quezon City, addressed to his Honor Feliciano R. Belmonte, Jr., to negotiate for the acquisition of a piece of land containing, more or less, two hundred ninety-two square meters and fifty square decimeters (292.50 sq.m.) suitable as the site for the construction of barangay hall of Barangay Bayanihan;

WHEREAS, the said piece of land located at Pelaez St., Barangay Bayanihan is registered in the name of Elizabeth M. Mahayag married to Mario P. Mahayag under Transfer Certificate of Title Numbered RT-60637 (3399103) issued by the Register of Deeds of Quezon City and that the registered owner is willing to sell the same to the barangay at reasonable cost;

WHEREAS, it is fair and appropriate for the City government to intercede and assist financially other local government units under its general supervision and control in the acquisition thereof considering that for so many years the officials and staff of Barangay Bayanihan have been performing their official duties and functions in a rented place not enough to accommodate and entertain their constituents who are asking for public services;

WHEREAS, there is a need to authorize his Honor Feliciano R. Belmonte, Jr., to negotiate for the acquisition of the property for the establishment and construction of barangay hall and as a place for the Barangay Bayanihan officials to perform their official duties and functions.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to authorize, as it does hereby authorize, his Honor Feliciano R. Belmonte, Jr., City Mayor, to negotiate for the acquisition of a piece of land containing, more or less, Two Hundred Ninety-Two square meters and Fifty square decimeters (292.50 sq.m.) registered in the name of Elizabeth M. Mahayag to Mario P. Mahayag with Transfer Certificate of Title Numbered RT-60637 (339103) issued by the Register of Deeds of Quezon City, and located at Pelaez St., Barangay Bayanihan, Quezon City, to be used as the site of barangay hall of Barangay Bayanihan.



