RESOLUTION NO. SP-**2170**, S-2003

A RESOLUTION URGING QUEZON CITY MAYOR FELICIANO R. BELMONTE, JR., TO GRANT FINANCIAL ASSISTANCE TO THE VICTIMS OF THE FIRE THAT OCCURRED ON APRIL 5, 2003 AT BLAS ROQUE COMPOUND, BARANGAY BAGBAG, QUEZON CITY COMPRISING OF FORTY (40) FAMILIES HOMEOWNERS/RENTERS/SHARERS AT TWO THOUSAND PESOS (P2,000.00) EACH, AMOUNTING TO A TOTAL AMOUNT OF EIGHTY THOUSAND PESOS (P80,000.00) TO BE TAKEN FROM ANY AVAILABLE FUNDS OF THE CITY TREASURY.

WHEREAS, a fire occurred on April 5, 2003 at Blas Roque Compound, Bgy. Bagbag, this City, rendering forty (40) family homeowners/renters/sharers homeless;

WHEREAS, Section 458 (1) (iv) of the Local Government Code of 1991 empowers the sangguniang panlungsod to "adopt measures to protect the inhabitants of the city from the harmful effects of man-made or natural disasters and calamities and to provide relief services and assistance to victims during and in the aftermath of said disasters or calamities and their return to productive livelihood following said events.


