
A RESOLUTION AMENDING RESOLUTION NO. SP-1610, S-2001, ENTITLED, "A RESOLUTION AUTHORIZING THE HONORABLE ISMAEL A. MATHAY, JR., TO SELL TO ATTY. EMMANUEL M. CARBONELL CITY ASSESSOR, THE MOTOR VEHICLE ASSIGNED TO HIM PARTICULARLY DESCRIBED AS 1994 NISSAN SENTRA A 1300, 4 DOOR SEDAN WITH PLATE NO. SEB 921, AT A PRICE TO BE DETERMINED BY THE CITY APPRAISAL COMMITTEE, SUBJECT TO EXISTING AUDITING RULES AND REGULATIONS", TO REPLACE THE VEHICLE SOUGHT TO BE SOLD WITH A NISSAN SENTRA BEARING PLATE NO. SEB-701.



SEB 921, at a price to be determined by the City Appraisal Committee, subject to existing auditing rules and regulations", to replace the vehicle sought to be sold with a Nissan Sentra bearing plate no.
