A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR FELICIANO R. BELMONTE, JR., TO ENTER INTO A NEGOTIATED CONTRACT WITH ALEXA TRADING & CONSTRUCTION, A DULY ACCREDITED CONSTRUCTION FIRM FOR THE IMPROVEMENT/ASPHALTING OF ALLEY 1, PHASE 1, BARANGAY PROJECT 6, DISTRICT I, QUEZON CITY, IN THE AMOUNT OF ONE MILLION SIX HUNDRED FIFTY-SIX THOUSAND TWO HUNDRED FIFTY-SIX PESOS AND NINETY-FIVE CENTAVOS (1,656,256.95)

WHEREAS, one of the streets in District I, this City that needs improvement is Alley I, located at Barangay Project 6;

WHEREAS, Alexa Trading & Construction, a duly accredited construction firm proposed for the improvement/asphalting of Alley I in the amount of One Million Six Hundred Fifty-Six Thousand Two Hundred Fifty-Six Pesos and Ninety-Five Centavos (P1,656,256.95);


