RESOLUTION NO. SP **2175**, S-2003

A RESOLUTION STRONGLY URGING THE CITY MAYOR, HONORABLE FELICIANO R. BELMONTE, JR., AS CHAIRMAN OF THE QUEZON CITY SCHOOL BOARD TO PROVIDE ONE (1) SERVICE VEHICLE TO THE PHILIPPINE ASSOCIATION OF EDUCATION SUPERVISORS WITH OFFICE ADDRESS AT 3RD FLOOR, DIVISION OF CITY SCHOOLS, QUEZON CITY, FOR OFFICIAL USE OF ITS OFFICERS AND MEMBERS.


