RESOLUTION NO. SP-2187, S-2003

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR FELICIANO R. BELMONTE, JR., TO GRANT FINANCIAL ASSISTANCE TO THE FAMILY OF THE LATE DOMINGO PURCIA, JR., WHO PASSED AWAY LAST NOVEMBER 8, 2002, WHILE SERVING AS BARANGAY KAGAWAD OF BARANGAY LOYOLA HEIGHTS, DISTRICT III, QUEZON CITY, IN THE AMOUNT OF THIRTY THOUSAND PESOS (P30,000.00) TO BE TAKEN FROM THE BUDGET OF THE OFFICE OF THE CITY MAYOR FOR FISCAL YEAR 2003, UNDER AWARDS AND INDEMNITIES, OR FROM ANY AVAILABLE FUND OF THE CITY TREASURY.

WHEREAS, given his service, loyalty and dedication to public service, it is but right that he be given due recognition and aid by the City which he has so meritoriously served.


NOW, THEREFORE,


