A RESOLUTION URGING THE HONORABLE FELICIANO R. BELMONTE, JR., CITY MAYOR AND CHAIRMAN OF THE CITY SCHOOL BOARD, QUEZON CITY, TO ALLOCATE/SET ASIDE THE PORTION OF THE CITY'S SPECIAL EDUCATION FUND FOR THE CONSTRUCTION OF ADDITIONAL CLASSROOMS IN DAMONG MALIIT ELEMENTARY SCHOOL, BARANGAY NAGKAISANG NAYON, NOVALICHES, QUEZON CITY.

WHEREAS, at present, Damong Maliit Elementary School has only one school building named "Mathay Building" with limited classrooms;

WHEREAS, due to inadequacy of classrooms, the more or less two thousand (2,000) students of the said school hold classes without any roof to protect them from the heat of the sun and rainfalls;

WHEREAS, it is the policy of the State to give priority to education to foster patriotism and nationalism, accelerate social progress, and promote total human liberation and development;

WHEREAS, in a letter dated February 10, 2003 of Mr. Joel P. Domopoy, President of Damong Maliit Elementary School General Parents Teachers Community Association, he stressed the need for additional classrooms in their school even in the form of a "makeshift rooms".


