RESOLUTION NO. SP- **2193**, S-2003

A RESOLUTION URGING THE BARANGAY COUNCILS WITHIN THE JURISDICTION OF QUEZON CITY, THRU THE HONORABLE CITY MAYOR, TO ADOPT AND REGISTER THEIR CORPORATE SEALS AS MANDATED BY THE LOCAL GOVERNMENT CODE OF 1991.

WHEREAS, Section 22 (b) Chapter 2, Title One, Book I of the Local Government of 1991 provides that:

“Local government units may continue using, modify, or change their existing seals: Provided, that newly-established LGU’s or those without corporate seals may create their own corporate seals which shall be registered with the Department of the Interior and Local Government: Provided, further, that any change of corporate seal shall also be registered as provided herein”;

WHEREAS, it has been noted that majority of the barangay governments in Quezon City have no existing corporate seal;

WHEREAS, the Department of Interior and Local Government issued Memo-Circular 92-30 treating on the policy guidelines on the creation, modification, change and registration of corporate seals of local government units.
